I am afraid that the results are not very helpful. Large confidence intervals. No trend if you look at the different tests. To get conclusive results we would need a larger study population. Such a study could be done. It would actually be easier to than the HHE follow up study since the children are now 7-8 years of age and tests differentiate better and are easier to administrate.

Roger Bernier contacted me about the study and I gave him the results over the phone. Roger was going to talk to the organizers of the IOM meeting. I could come to Boston to present if there is interest.

I have done one more thing. I have checked the Swedish hospitalisation register the diagnosis autism and found 35 children among the children who participated in the trial. The reason for the small number is, that not all cases of autism are hospitalised. This is a select probally more severe cases as well a children with autism who were hospitalised for other reasons. It probably about a third of all cases. However for this group of children it is still interesting to do a coparison.

Unfortunately, our Department of Developmental Services (DDS) tells us, there is a real lag in children with autism getting into their system as diagnosis is frequently not finalized and they're not referred to the DDS service system until up to age 5 years or even older. Thus, data for birth cohorts of less than 5 years earlier are quite incomplete, and even data for birth cohorts 5-7 years earlier are often still below what they finally settle out to be. DDS updates their tabulations of caseload every 6 months, and we used their fall 2000 tabulation - the latest figures available then for our MMR/autism paper.

I could contact DDS to see if they've done or could do an updated tabulation. I suspect that would make a few very small increases in numbers of cases for birth years 1990-94 and provide a fairly complete 1995 birth year caseload count, and a somewhat less complete 1996 birth year caseload count. Beyond 1996 the data will be very incomplete.

Thank you for your letter and please excuse my delay in answering - I have been away travelling abroad for two weeks.

It is correct that Sweden has not used pediatric vaccines containing thiomersal for many years now - officially it was abandoned in 1989 but since the stock remaining was sold out, the Swedish Medical Products Agency claims that we should count pediatric vaccines as thiomersal-free since 1992.

I know that also Denmark has abandoned the use of thiomersal quite some time ago but I don't know when. I would propose that you contact "Michael Stellfeld" <MSF@ssi.dk> at theDanish Seruminstitute (SSI) to get a precise date.

I am very well aware of the recent concerns in the US over thiomersal. On the expert committee (Group 15 for Vaccines and Sera) of the European Pharmacopoeae I represent Sweden and had in vain tried to get Europe to ban its use in single dose vials until the US interest in the issue (it is removed also from multidose vials in Sweden but that might have been too much to aim for in a first step). In the latest version of the monography of the EU Ph on "Vaccines for Human Use" it now states that single dose vials should not contain a preservative — without the 10 line exceptions that used to follow the statement. I thanked Neal Halsey in the name of European infants for the help when I met him again last year.

Diane,

Thanks for your mail. I have not forgotten about Christoffer Gillberg. Only it is taking time to track him down. In Sweden the time of the year when it is pleasant, some would say bearable, to be outside is brief. As a result everybody is by law entitled to four consecutive weeks of vacation during summer. Whole offices are closed and Chritoffer Gillberg's office is one of them. I have not even been able to find out where he is or when he will be back. Eventually I will get hold of him and you will hear from me a soon as I have something to report.

At SMI we are working on two Immunisation register projects. The project to establish Swedish register is in a planning stage. An interagency committee has been formed and we are working on the specifications for the register. We are looking for a solution which avoid double data entry and we want to be able to link the register with other national health registers in order to carry out the vaccine safety and vaccine efficacy studies. There are of course a number of issues to be resolved, all very familiar to you. We plan to have a pilot register in operation late this year and will know in January if we get funding for full scale implementation. The second project "Development of Vaccination Registers in the European Union" (2000/SID/017) is funded by the EU General Directorate for Health and Consumer Affairs. The objectives of the project are to describe existing and planned immunisation registers, to identify potential areas for collaboration and to propose a plan of action. All EU member countries accept France participate in the project. We will carry out a survey this fall and collect further information through site visits next year. A proposed meeting to discuss findings was not funded. We now seek funding for such a meeting from other EU sources.

I have indeed talked to Rob Linkins about the two projects and we made tentative plans to meet in November, when we will both attend meetings in Cadiz, Spain. 

1) Haemophilus influenzae type b vaccine was introduced in Denmark in 1993. Tetanus conjugated PRP-T vaccine manufactured by Aventis Pasteur is used. This vaccine do not contain thiomersal. So far, Hepatitis B vaccine is used for risk groups only, i.e. not in the general vaccination programme. Engerix manufactured by GSK is used - a preservative free preparation of this vaccine has been available in Denmark since April 2001.

Dr. Gillberg,

I am the (acting) Deputy Director of the U.S. Centers for Disease Control and Prevention's (CDC) National Immunization Program. In the United States there are concerns that the thiomersal contained in childhood vaccines could have contributed to a perceived increase in the incidence of autism (and other neurologic disorders). The addition of thiomersal in routine childhood vaccines was stopped in 1999 in the US, but the question of any adverse events is being studied by a special committee of scientists under our Institute of Medicine (IOM).

The US does not have a system to routinely capture data on cases of autism. Consequently, we at NIP do not have good information on the prevalence or incidence of autism in US children and whether it has increased over the past 10 to 20 years. We are seeking other developed countries who have limited use of thiomersal in their vaccines and good data on autism rates over time to see what their experience has been. Sweden is one possibility (we are also talking to researchers in Denmark)

I have reviewed some of the literature on the incidence of autism and know that you are a recognized leader in that field. I also believe that you have conducted surveys for autism over time in a specific area in Sweden. We would be very interested in speaking to you or your colleagues about the data you have.

Because our IOM committee's work is in process and we expect them to issue their report in the next several weeks, we expect increased public concern and questions in the near future. Consequently, if you are willing to talk to us about your work, we would like to meet with you this month. We have tentatively scheduled a trip to Denmark on August 23; we could easily include a visit to your University in that same time period.

Please let me know if you are willing to meet with us and if the time period we suggested is agreeable. (It is possible that Dr. Harald Heijbel may be contacting you also on our behalf)
